Novice, Intermediate, and Advanced Drivers

Please bring this form to the on-site tech inspection at Type-R Expo, which is held during registration in the paddock the evening before the event begins and the morning of the first day of the event. All vehicles that will be on the track will be subject to and must pass the on-site technical inspection.

Instructors and Staff

You must have another staff member or instructor complete a tech inspection of your car (peer inspection). This form must be completed and signed by yourself and the person completing tech on your car and presented to the safety steward or lead instructor during the on-site tech inspection.

If you have any questions regarding this form, or the requirements to pass this inspection, please contact the event organizer, lead instructor, and/or safety steward for clarification (safety@itrexpo.com). Please be mindful of your fellow drivers — any cars that have not gone through tech inspection the evening before the event will be inspected the morning of the event.

Any tech that needs to be completed after the driver's meeting on Wednesday will be subject to staff availability. If this happens there's a good chance you will miss track time.

PLEASE NOTE: Each driver must submit their own tech inspection form, even if multiple drivers are using the same car.

The following items (next page) must be in compliance in order to pass the on-site technical inspection. You will place demands on your car that far exceed those encountered in normal street driving. You will be required to repair or replace defective or worn items at your own expense prior to being allowed on the track.
